Solent Transport (<http://www.solent-transport.com/>) is a partnership between Hampshire County Council, Portsmouth City Council, Southampton City Council and the Isle of Wight Council. It is responsible for planning transport improvements in the Solent area.

9 National Productivity Investment Fund Announcement

The Department for Transport, (DfT) recently announced that Hampshire will receive £5.1m from the National Productivity Investment Fund. This funding is in addition to other DfT grants and Hampshire's own funds which form the structural maintenance budget of approximately £45m for 2017/18.

The Government states that this fund should help to improve local road networks. Hampshire fully supports this Fund and will use it to improve our local road network and where possible provide upgrades to our highway infrastructure. As part of this arrangement the Government have asked that Hampshire provide information for the public on how we will spend this money.

We are currently looking at opportunities to enhance our anticipated structural maintenance programmes for 2017/18 and intend to extend our programme in the following areas.

- adding to our structures strengthening programme
- replacing and upgrading some of our older traffic signal installations to improve efficiency and reduce congestion
- further carriageway resurfacing with an emphasis on strengthening, making the roads more resilient and improving links to new development.

There are a number of schemes being considered and subject to programming will become a defined list in the next few months.

To ensure that Hampshire spends this money in 2017/18, pre-planning for road space, detailed design and arrangements with our highway contractor are already in hand. We are anticipating that this works programme will be completed before the end of December 2017.
