The current Local Plan was adopted in April 2017 and continues to perform well in making decisions on development, however, in response to significant changes to national policy, a review is required to ensure it remains up to date.

The first stage of the Local Plan review, the Issues and Options consultation and call for sites, has now ended and all comments received and key issues raised are now available to view via the consultation link below. The comments received will help inform the drafting of the revised plan, which will be published for public consultation in early 2020.

Adopted Local Plan

The Central Lincolnshire Local Plan was adopted by the Central Lincolnshire Joint Strategic Planning Committee (CLJSPC) on 24 April 2017 and it now replaces the Local Plans of the City of Lincoln, West Lindsey and North Kesteven District Councils. Housing Growth in Medium and Small Villages (Local Plan Policy LP4)
