C3: Dwelling Houses	1 bedroom: 1 car space per dwelling plus 1 secure

Note:  Parking requirements for Supported Living Accommodation or Older People's Housing shall be calculated on a site-by-site basis, due to the varying requirements of each development in terms of residents, staff and visitors.  Secure cycle spaces should be within 100 metres of the property. Where appropriate, secure space for mobility buggies should be provided within the development at a ratio of 1 per dwelling.  1 car space and 1 secure cycle space per 2 bedrooms.
