



## North Devon and Torridge Local Plan – Adoption Statement

In accordance with Regulation 26 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) this Adoption Statement hereby gives notice that on 29<sup>th</sup> October 2018 North Devon District Council and Torridge District Council adopted the North Devon and Torridge Local Plan 2011-2031 as a development plan document, in accordance with s23 of the Planning and Compulsory Purchase Act (as amended).

The North Devon and Torridge Local Plan was the subject of an independent examination conducted by Mrs Wendy Burden BA(Hons) DipTP MRTPI, an Inspector appointed by the Secretary of State. In her report published on 13<sup>th</sup> September 2018 the Inspector confirmed that the North Devon and Torridge Local Plan is sound and legally compliant subject to the application of recommended Main Modifications and thus is able to be adopted by the District Councils.

The recommended Main Modifications have been included in the adopted North Devon and Torridge Local Plan, which now carries full weight in the consideration of planning applications. The "saved" policies of the North Devon Local Plan and the Torridge District Local Plan are now superseded by the policies of the North Devon and Torridge Local Plan.

Any person aggrieved by the adoption of the North Devon and Torridge Local Plan may make an application to the High Court under Section 113(3) of the Planning and Compulsory Purchase Act 2004 on the grounds that:

(a) the North Devon and Torridge Local Plan is not within the powers conferred by Part 2 of the Planning and Compulsory Purchase Act 2004; or

(b) a procedural requirement has not been complied with.

Any application must be made promptly and in any case no later than six weeks from the date on which the Local Plan was adopted.
